**Informed Consent:** As the parent/guardian of the registrant, I agree that we will abide by the rules of Doral Soccer Club Inc. (DSC), the state association (FYSA, USCLUB), and all affiliated organizations. I acknowledge that my/our child wishes to participate in soccer during the current season and understand that this participation carries inherent risks. These risks range from minor injuries to severe injuries, including the possibility of death, paralysis, or other serious, permanent disabilities. I accept these risks as a condition of my/our child's participation.

Insurance Notice: All injuries must be reported within 5 days of the date of the injury.

- All competitive teams will participate in three mandatory training sessions per week.
- All ECNL / RL teams will participate in four mandatory training sessions per week.

**Note:** The club uniform kit, league expenses, tournament fees, and any additional events will incur separate cost. Teams that begin training in July will be charged \$200.00 for the training month.

This document constitutes a legal and binding contract. Regardless of whether your child participates in only a few games or the entire season, you are obligated to make full payment to Doral Soccer Club Inc. (DSC) for the season specified above. By signing this contract, you agree to assume full responsibility for any attorney's fees incurred in efforts to collect the total amount due.

All payments are managed and processed through PlayMetrics. Cash or check payments may be accepted but must be paid in full. A fee of \$35.00 will be assessed for any returned checks.

**Note:** Prices will vary based on the players' placement within their respective teams and the leagues in which the teams will participate during this season.

All payments are final and non-refundable.

As the parent/guardian of the registrant, I hereby acknowledge that failure to meet my financial commitments may lead to the registrant being classified as "Not in Good Standing" with the club and its affiliated state organizations. Consequently, the registrant's participation privileges will be suspended until the obligations are met by the due dates. Furthermore, this status will affect the registrant's eligibility to register with any other state affiliated organizations.

\_\_\_\_\_ **Parent's Initials**

As the parent/guardian of the registrant, a member of a competitive team affiliated with Doral Soccer Club, I acknowledge my responsibility to contribute to all coaching fees, referee fees, travel expenses, league fees and/or tournament fees for the season. These fees, as determined by the team, will be evenly divided among all team members, and must be paid by the specified deadline. Failure to fulfill these obligations may jeopardize both the team's and the players' participation in the respective event, with the exception of major injuries which will be exempted.

As the parent/guardian of the registrant, I acknowledge that certain tournaments throughout the season require mandatory attendance. Any player who fails to attend such tournaments may be subject to penalties determined by the coach, at their discretion. However, players with major injuries will be exempt from this requirement.

Doral Soccer Club does not offer transportation services for practices or games. Parents assume full responsibility for arranging any carpool arrangements with other team members. Doral Soccer Club bears no responsibility for any accidents that may occur while your child is being transported to a team event in a personal vehicle or hired transportation.

As the parent/guardian of the registrant representing Doral Soccer Club, I acknowledge that the player's behavior must consistently reflect the highest standards both on and off the field while wearing the Doral Soccer Club uniform, in accordance with our club's code of ethics. The directors of Doral Soccer Club reserve the right to impose penalties or terminate the player's contract based on their discretion and the severity of the situation.

As the parent/guardian of the registrant, I agree to procure the full uniform kit, and the player must wear the complete uniform during training sessions, league matches, and tournaments. Any alterations to the Doral Soccer Club uniform requires the explicit consent or approval of the club.

As the parent/guardian of the registrant, I acknowledge that attendance at team training sessions is compulsory. Players who fail to participate in practices may face penalties determined by the coach's discretion. Please note that Doral Soccer Club bears no responsibility for training sessions canceled due to weather conditions or decisions made by local or state authorities.

As the parent/guardian of the registrant, I agree to adhere to Doral Soccer Club's policy, which prohibits players from guest playing or practicing with any other teams affiliated with organizations such as FYSA or USCLUB. Doral Soccer Club directors reserve the right to impose penalties or terminate the player's contract for non-compliance with this policy.
